Bhramappa Yenappa and Others <i>versus</i> Messrs. Shanorji Palanji and Co. P. Ltd. (Bombay) Applications Nos. 139 to 141, 143 to 147 and others of 1969. (Payment of Wages Act, 1936—Claim for payment of leave salary—Section 35 and 36 of the Bombay Shops and Establishments Act, 1948—Applicants claimed leave which they claimed to have enjoyed but for which they have not been paid leave wages. Claim opposed by the management on the ground that the applicants have not been granted any leave and the question of making any payment, therefore, does not arise.)	119
Sections 35 and 36 of the Bombay Shops and Establishments Act, 1948 clearly indicate that leave must be granted by the Employer then any leave will be encashable. Held—further if workers have not been sanctioned leave they will be deemed to have remained absent and cannot be then said to have been on authorised leave. Since applicants have failed to prove that they have applied for leave either orally or in writing, they are not entitled to encashment of leave which they have not enjoyed at all with the permission of the management claims are thus rejected.	lit
Hussain Alibahi <i>versus</i> Swadi Automobiles, Bombay (Application No. 142 of 1969).—(The Payment of Wages Act, 1936)—Applicant claims retrenchment compensation leave wages on retirement as per standing orders—Claim rejected so far as retrenchment compensation was concerned saying that "Retirement on Superannuation is no retrenchment" leave wages claim upheld.)	622
<i>versus</i> Virgo Co-operative Housing Society Ltd.; Bombay-50. (Application No. 928 of 1969).—The Payment of Wages Act, 1936—Applicant claims for arrears of dues of overtime wages after termination of service—Delay prayed to be condoned as it was not paid while in service and waited in good faith for the same—Employer questioned the jurisdiction of the Court—However the claims was rejected being not maintainable.)	1584

Gracias and Others <i>versus</i> Messrs. Famous Cine Studios Ltd., Bombay. (Applications Nos. 1092-1156, 1158-1173 and 1276 to 1284 all of 1970)—Claim for annual increment of the said Award. Payment made after termination of contract was refused. Applicant now employed for the same Change of employment implemented after the expiry of the statutory period from the date of notice of change served under Section 9A of the Industrial Disputes Act, 1947 was stand rejected saying that the Authority has no jurisdiction to hear the application. Payment of the same in view of the facts stated above.	745
Chandubhai S. Patel <i>versus</i> Messrs. Quality Instruments Co., Bombay-69. (Application No. 4461 of 1970).—Payment of Wages Act, 1936—Claim for unauthorised suspension by way of deducted wage. Payment of Wages Authority rejected—As per directions to the Authority.	391
Noor Mohammed Alibux and Others <i>versus</i> Messrs. Film-laya Pvt. Ltd., Bombay-58 (AS). (Miscellaneous Application No. 144 of 1970).—The Payment of Wages Act, 1936. Original 45 applications treated as a single application. Default by one common order—Application by the representative of the applicants requesting for authorisation to act on behalf of the employees not necessary—Held further that the application dismissed not on merits and fell within Rule 8 of the Payment of Wages Rules. Remedy open to the applicant is therefore by way of restoration of application for dismissal—Held further that one application for restoration of the applications dismissed for default is maintainable as the group applications are treated as a single application. Held the submission of the application is within the prescribed time limit and non-appearance has been satisfactorily explained to the Court. Original Applications are therefore restored).	500
Noor Mohammed Alibux and Others, <i>versus</i> Messrs. Film-laya Pvt. Ltd., Bombay. (Application Nos. 108-152 of 1970. Restd Nos 134-178 of 1970).—The Payment of Wages Act, 1936—Claim for arrears of Wages as adjustment benefit under an Award—Elementary principle of Limitation Established principle of Law of Evidence Tribunal awarding wage scales and fixed d. a., instead of existing monthly consolidated salaries—Expression present pay nowhere defined or explained—In the absence of any basis for calculation of arrears not admitted or agreed upon by the parties, held the Authority cannot issued direction assuming certain basis for such calculations—Direction for payment issue of, in favour of deceased applicants).	1025

Shantaram Devu Parab and others versus Messrs. Gansons Pvt. Ltd., Bombay (Application No. 2225 of 1968 and 4337 of 1969).— <i>The Payment of Wages Act, 1936—Claim for wages Weekly off days—Under Standing Orders, weekly holidays are paid holidays—Daily rated workers paid monthly, whether entitled to paid weekly holidays—Interpretation of certified Standing Orders not an incidental question to be dealt with by the Authority under the Payment of Wages Act—Claim dismissed for want of jurisdiction.</i>	890
Sinca Soma versus The Shipping Corporation of India Ltd., Bombay-1. (Application No. 970/C-141 of 1969).— <i>The Workmen's Compensation Act, 1923—The applicant workers slipped from the gangway staircase, injured and hospitalized. Permanent partial disablement finally assessed at 8 per cent. Claimed compensation on the basis of Medical Certificate admitted in evidence by the consent of the parties. Held Medical evidence being only opinion evidence could not be decisive of the question of deciding the loss of earning capacity of an injured workman. Diminution or destruction of physical capacity as disclosed by the Medical evidence and the extent to which the injured person is thereby disabled from performing the duties which a workman of his class or ordinarily performs and from earning the usual remuneration paid for such duties are decisive factors. In view of the re-employment, on the same amount of wages and that too on the work on the Board which is agreed to be made available to the applicant worker till he retires at the age of 60 years, it is held that there is no disability to earn wages as before and the appellant failed to discharge the onus of proving loss of earning capacity and consequently is not entitled to any compensation.</i>	257
