CASES UNDER LABOUR LAWS

P. J. Ovid, Assistant Commissioner of Labour, Bombay 1486 versus Messrs. Bharat Barrel and Drum Manufactures Co., Bombay and Others.-Payment of Bonus Act, 1965—section 19 read with Sections 28 and 29 prosecution was launched against the management and its Directorsunder section 10 the accused were bound to pay every employee bonus for the accounting year 1969-Same was not paid within stipulated time and prayed for extension at the eleventh hour-Government refused the same-but the accused pleaded for extension under the guise that as no reasons were forthcoming for refusal and hence applicants case may be rejected—However it was held that the accused No. 1 was guilty and so fined the management Rs. 75 and acquitting the others by giving benefit of doubt.

CASES UNDER LABOUR LAWS-conid.

Shri Dhondy Rabajee Shinde and Ors. through A. T. Husraiani, the B. E. S. T. Worker's Union, 42, Kennedy Bridge, Bombay-4 versus the B. E. S. T. undertaking, B. E. S. T. House, Bombay-1. - Payment of Wages Act, 1936 section-15. Applicants of B. E. S. T. Undertaking working in stores Department, Bus Engineering Control Section claim overtime wages and objected illegal deductions from their wages accordingly. The Undertaking rejects the claim under the guise that the stores department is not covered under the Factories Act, 1948. The views of the undertaking were rejected saying that the work of the applicants in stores Department as well as Bus Engineering control section is incidental to and connected with the manufacturing works of the Factory and hence they are covered by the definition of "Worker" under section 2(1) of the Factories Act and are entitled to claim wages, the service Regulation relied upon by the Undertaking is no bar to the applicants claim of overtime wages, at the double rate. Hence the claim was upheld and the undertaking was directed to pay the dues accordingly.

Carlos Gomes versus Messrs. J. P. Dias and Co., Bombay-1.— Payment of Wages Act 1936, Section 15 -- Claim of wages by applicant subvequently reduced in mutual agreement termed as loan agreement and hence not accepted. The resp ondent argued that the relation of Master and servant does not exist and the claim' looses character of wages the moment it is reduced to the mutual loan agreement. So far as jurisdiction was concerned it was held, that the present Court was competent to entertain the claims-the wages defined under section 2(vt) which had become due and payable on fulfilment of the term of contract of employment or for the work done in employment could not be converted into loan transactions. It cannot be interpreted as simple contracts of money debts-it offers better evidence of the acceptance of liabilities to pay the dues. Hence the applicants claim is up held.

CASES UNDER LABOUR LAWS-II

A settlement was arrived at between the Maharashtra State Co-operative Marketing Federation Ltd., Bombay and the Apex Marketing Employees Union, Bombay relating to wage scale, gratuity, medical aid etc. on Bombay as required. Under section 12(3) of the Industrial Disputes Act, 1947. The said settlement is to remain in force for a period of three years i.e. till 31st December 1973. The Notable feature of the settlement is provisions of the Medical aid Fund. The agreed terms of Settlements in this behalf between the parties are as under.
